3. Supervising the Board of Management by the Board of Directors:

In 2024, the Company's entire plan focuses on the Binh Giang project. This is a particularly difficult year for the Company. The People's Committee of Hai Duong province issued Decision No. 456/QĐ-UBND dated February 29, 2024, approving specific land prices when the State allocates land in the first phase for the Binh Giang Project. Land prices

increased abnormally, exceeding the Company's implementation capacity, seriously affecting the Company's production and business plans in 2024 and the subsequent years. The Board of Directors has paid attention and regularly directed the Company's Executive Board to research and propose solutions to remove difficulties and obstacles. Up to now, the difficulties and obstacles have been basically removed, thereby bringing positive results and maintaining stability in the Company's production and business activities. Some activities and results achieved are as follows:

- Investment:

+ Binh Giang Project: Work with relevant agencies of Hai Duong province and the central government to review and resolve the Company's recommendations on issues related to determining land prices to calculate land use fees and land rents at the project; approve project adjustments; request approval to sell project land plots approved by the Hai Duong Provincial People's Committee on July 22, 2024; complete procedures for deducting site clearance costs from land use fees in August 2024; complete procedures for signing an appendix to the contract to extend the project implementation period in September 2024; coordinate with local authorities to organize the enforcement of land recovery for the remaining rice fields on October 10; complete procedures for applying for traffic connection and irrigation connection licenses as planned; deploy documents, procedures, and organize the selection of contractors to implement the project from November 25, 2024.

+ Dong Tam-Yen Bai Project: Select contractors to prepare and review construction drawing design documents and organize the preparation of construction drawings; implement investment project adjustment procedures; follow up with relevant local agencies in site clearance compensation.

+ CC3 Project, Bac Ninh: Implement procedures to request approval to adjust detailed planning (increase the height from 7 floors to a maximum of 27 floors) with local government agencies.

- Through regular and extraordinary meetings, the Board of Directors reviewed and evaluated the implementation of instructions, compliance with the provisions of the Law; the Company's Charter, resolutions of the General Meeting of Shareholders and resolutions and decisions of the Board of Directors regarding the Company's Executive Board and other management staff in the Company. Thereby, it can be seen that the Executive Board complies with and basically fully implements the instructions.

4. Activities of the Board of Directors' subcommittees

Currently, the Board of Directors has not established any subcommittees. The implementation of policies and activities is directly directed by the Board of Directors to the Executive Board to implement the decisions and resolutions of the Board of Directors; assigning 01 person to act as the Company Administrator, Secretary of the Board of Directors, to assist the Board of Directors in synthesizing, reviewing and reporting on the Company's business lines. In addition, when necessary, the Chairman of the Board of Directors directly requests the Director or department/office to make a report, or through working meetings with the Executive Board/department heads to handle the work.


